Job Summary

This position is responsible for the movement of cargo through the Port of Tacoma; for planning and coordinating labor and equipment requirements at marine terminal facilities; for maintaining communications with cargo and ocean carrier customers and their agents, U.S. Customs officials, USDA, USCG, Tugboat operations, the Port's customer service and maintenance departments; for performance of supervisory duties and responsibilities; and for cost analysis and rate development support.

Essential Functions and Duties

- Plan and coordinate manpower and equipment requirements including responsibility for coordinating with the Port's Maintenance Department, and for establishing work schedules and priorities for cargo movement.
- Maintain communications with labor, customers, railroads, Port Security and government agents; facilitate vessel berthing and the efficient handling, storing, clearance and movement of cargo.
- Supervise ILWU forepersons/supervisors involved in movement of cargo. Supervise, manage and evaluate ILWU Local 22 Rail Car and Freight Coordinators.
- Responsible for the safe movement of cargo through the Port of Tacoma. Ensures that
 all staff are working in a safe manner. Advise the safety manager of hazardous working
 conditions or potential safety hazards in the marine terminal areas and assist in
 resolution of liability claims with the Port's insurance agent and claims manager.
- Prepare necessary reports and documentation in connection with the cargo movement, i.e., rate quotes, reports on injuries to personnel or damage to cargo, containers or equipment; daily reports on ship movements and terminal activities; instructions for other superintendents detailing planned operations scheduled for other shifts, billing for labor, materials, and equipment in handling project cargo, billing for rental of all port owned equipment.
- Lead meetings and communication with customers, railroads, Puget Sound Pilots, security, maintenance, ships agents, stevedores and tug boat captains and others as necessary to safely and efficiently move cargo through the Port of Tacoma.
- Compile, analyze and maintain statistical data on cost and productivity for specific activities.
- Communicates with the billing department regarding the movement of cargo under the Port of Tacoma's tariff. Maintain effective working relationships with union leaders and administer labor union contracts.
- Maintain contact with the mainline railroads and Tacoma Rail through conference calls; update mainline railroads and Tacoma Rail on train schedule changes, train changes and car requirements.
- Develop methods of handling new commodities and devise improved cargo handling methods; keep abreast of new developments in equipment and cargo handling techniques, and recommend capital improvements.

Required Experience and Education

Bachelor's Degree from a Maritime Academy or in the area of business with specialization in transportation or related discipline.

Minimum of five (5) years' as a stevedore maritime agent or railroad operations. Experience working with cargo related labor force and shipping agent is required. Five (5) years supervisory experience and knowledge of hazardous materials regulations is required.
